Dear Friends and Family, Former ARL Members and/or GLGM Patrons,

It has been a while since I have communicated with you. After the IRS and the Department of Injustice literally locked the doors to the GLGM office in February of 2004, my wife, Kookie, and I decided we wanted to go live somewhere where we could, as one of our friends put it “*you don’t fight for freedom, you live it*”.

That sounded good to us. I had been fighting to help regain our lost freedoms in America for over 25 years. It was time for a change.

We had both been to Panama on more than one occasion. We liked the country and the people. So we moved. For the most part it was a delightful two and one half years.

However, the IRS did not like the fact that I was not in prison along with Irwin Schiff, Larkin Rose, etc. I am told they tried five times over that 2 ½ years before they could get a Grand Jury to indict me.

They made a big deal out of it by charging Wesley Snipes, the actor, Doug Rosile, the tax preparer and myself in a conspiracy to defraud the U.S. government. Doug had prepared a 1040X Amended Tax Return to get back money Wesley had paid in 1997 using the 26 USC 861 Argument. Because Wesley was a member of ARL and Doug prepared the Amended Return in the ARL offices, I was also charged, as ARL would have gotten a percentage of the refund. However, no refund was ever sent by the IRS.

The FBI kidnapped me from Panama on Nov. 1, 2006. I was flown to Miami, officially “arrested” by IRS-CID agents and taken to the U.S. District Court in Ocala, Florida. Although I denied being the “all caps” name Defendant, denied the Court’s jurisdiction, refused a lawyer and demanded to see a Verified Complaint by the Plaintiff and Affidavits of Probable Cause required by the Fourth Amendment to issue an Arrest Warrant (they had none), the Magistrate Gary Jones had the U.S. Marshalls put me in the Marion County jail with no bond.

I was there until March 30, 2007. The Marshalls then moved me to the Lake County jail because I was continually complaining that I had virtually no access to the *outdated* Law Library (15 total hours in 150 days). Lake County was *supposed* to be better. It is worse! I have no doubt the Marshalls knew this. I had asked repeatedly to go to Citrus County, where

they have a Law Library with computer and Internet access. Even though Citrus County is much closer to Ocala, they just did not want to put me there. Wonder why?

Nevertheless, I have been blessed with knowing many fine researchers around the country. They have uncovered new information and, as a result, new strategies, which have been sent to Kookie to get to me for review. God bless them all! I have kept Kookie very busy making it difficult for her to keep you all informed of my progress. Therefore, from now on, I will be filling you in on things as they happen. I want to thank all of you for your support and prayers. The Bible says, "The prayers of a righteous man availeth much." Kookie and I believe that is true and thank you again for them.

Propaganda? Just to show you how much misinformation is disseminated in newspaper "articles", one came out in the Orlando Sentinel on June 10th "updating" my case. It was written by Robert Perez. A key statement in that article was "Kahn agrees to be jailed without bail while a not guilty plea is entered." Robert Perez was contacted and he stated that he did not write that part. His editor was contacted and he stated that that part was taken from a November 9th article. Question: Does anyone out there honestly believe that I said that I want to go to jail and that I don't want bail? People reading this stuff actually believe it! I can tell you that statement is a bald faced lie! Typically, most of these type of "articles" are actually press releases given to them by the Department of Justice or the IRS.

I could go on as there are numerous other, to put it kindly, "misstatements" in the "article", but you get the idea.

Final Note: Since Kookie wrote the last update on March 28, 2007, we have been sent much information and been contacted by several people & organizations regarding suggestions for the legal strategies I might want to consider. In putting everything out on the table and contemplating my best plan of defense and tactics for getting released, (although I have nothing against the US Observer), I felt that there were other options that would be more suitable for my immediate needs. Those who donated funds to employ the services of the US Observer, were contacted and notified of this change of plans for use of the funds and offered a return of their donations, if asked. For those of you who donated anonymously, it is important for you to also know that my intention is to be totally honorable using these funds in the best way to get me released and/or fight the fight. If you would like a return of your funds, please let Kookie know and she will get it to you.

I am told that the first two updates that Kookie sent out will be put on the www.FreeEddieKahn.com website shortly for those of you who have not been kept up to date thus far, or you can return an email requesting them to be sent to you.

As always, if you do not wish to continue receiving these emails please return this

email with unsubscribe in the subject line. At the same time if you know someone who is not on the email list and would like to be they can email requesting to be added.

Well I have to go now. I've got to get back to my studies. Take care. God bless you all. Hopefully, I will see you soon. The contact information for Kookie and myself is listed below.
